

ORDINANCE #7
TOWN OF SCHROON

NOTICE OF ADOPTION OF ORDINANCE NO. 7 OF THE TOWN OF SCHROON, ESSEX COUNTY, NEW YORK, DESIGNATING CERTAIN TOWN ROADWAYS OF SUCH TOWN AS UNCONGESTED AND SAFE FOR SNOWMOBILE TRAVEL ON THE SHOULDERS THEREOF; ALSO, PERMITTING SIMILAR ADDITIONAL USAGE ON OTHER DESIGNATED TOWN HIGHWAYS.

PUBLIC NOTICE IS HEREBY GIVEN, of the due adoption by the Town Board of the Town of Schroon, Essex County, New York, on December 3, 1970, of an Ordinance, viz:

SECTION 1. DESIGNATION OF HIGHWAYS, ETC.

(a) That, pursuant to the provisions of Section 8-0303, Sub. 2 (c) (3) of the Conservation Law, and Section 10 (1) ii (a) 6 of the Municipal Home Rule Law, the following Town Highways, all located and situate within the Township of Schroon, Essex County, New York, are hereby designated as uncongested and safe for snowmobile travel on the shoulders thereof, viz:

Lock Muller Road
Potash Hill Road
Young's Road
Vanderwalker Road
Charlie Hill Road
Hayes Road
Horseshoe Pond Road
East Shore Road
Letsonville Road
Pyramid Road
Crane Pond Road to State Parking Lot
Alder Meadow Road
South Road
Tyrrell Road
Turnip Patch Road
River Road
North Shore Road
Fraternal Land Road

(b) In addition to the permissible use of certain public highways, as above provided for, pursuant to Sec. 8-0303, Sub. 4(a) of the Conservation Law, and other statutes above mentioned, there is hereby permitted the operation of snowmobiles on the roadway, shoulder and inside bank (in case the outside bank or slope is impassable), of the following Town Highways within said Township of Schroon, viz:

Crane Pond Road - from State Parking lot to end;
Charlie Hollow Road - from the Charlie Hill Road to the Town Line;

The Horseshoe Pond Road - from the Chlorinator Building to the Hoffman Road;
The Johnson Pond Road - from the Letsonville Road to the Town Line;
The Flemming's Pond Road - from the Letsonville Road to the Town Line;
The Thilo Road - from the Charlie Hill Road to the Town Line.

(c) Each of the above designated highways shall be identified by road markers in such manner as may be provided by the Rules and Regulations of the State Commissioner of Transportation, in accordance with said Statute.

SECTION 2. VIOLATIONS; PENALTIES.

(a) Any person who shall violate any provision of this ordinance, or any duly promulgated Rule or Regulation of the Parks and Recreation Department of New York, shall be guilty of a violation and be punishable by a fine of not more than One Hundred Dollars (\$100).

(b) The State Parks and Recreation Commissioner may suspend or revoke a dealer's registration certificate, a snowmobile safety certificate, and permits for special events, issued pursuant to applicable provisions of such Statute, upon satisfactory proof of violation of any provisions thereof or any rules and regulations promulgated pursuant thereto. Upon said suspension or revocation all rights and privileges accruing to such registrant, youthful operator, or permittee, shall terminate.

SECTION 3. EFFECTIVE DATE.

This Ordinance shall take effect immediately upon its due passage and adoption, and its required public noticing, and a copy thereof to be filed with the State Commissioner of Parks and Recreation.
