RESOLUTION# 154 Approve Water Tap for Daniel Sullivan, 980 US Rte 9

Councilman Gero moved a resolution to approve to install a new 1 ½" water connection to replace the ¾" water line for Daniel Sullivan Tax Map #147.13-4-6.000 located at 980 US Route 9, seconded by Councilman Thompson; carried.

RESOLUTION# 155 Waive Sewer Grease Trap fines

Councilman Thompson moved a resolution to waive the Sewer Grease Trap Fines for Pitkins Restaurant, Alpine Pizza, Senior Citizens and the Timberwolf in the amount of \$500.00 for each business and going forward we need to make sure all businesses are in compliant to Ordinance #6 and yearly inspections are being done or fines will be issued if they are not in compliance, seconded by Councilman Gero; carried.

SECTION 6. Any business that serves or prepares food is required to have a grease trap or separating system, they are necessary for the proper handling of liquid wastes containing grease in excessive amounts, or any flammable wastes, sand, or other harmful ingredients:

except that such interceptors shall not be required for private living quarters or dwelling units. All interceptors shall be of a type and capacity approved by the Superintendent, and shall be located as to be readily and easily accessible for cleaning and inspection. Where grease traps or interceptors are being utilized, they shall annually submit cleaning and disposal records to the Town Sewer Department, those with grease traps will send copies of their hauler slips or bill and those with separators' will have to submit maintenance records and disposal records. An annual Inspection will be done. Interceptors shall be installed in accordance with current NYS Plumbing Codes.

ARTICLE VIII. PENALTIES

SECTION 1. Any person found to be violating any provision of this ordinance except Article VI shall be served by the Town with written notice stating the nature of the violation and providing a reasonable time limit for the satisfactory correction thereof. The offender shall, within the period of time stated in such notice, permanently cease all violations.

SECTION 2. Any person who shall continue any violation beyond the time limit provided for in Article VIII, Section 1, shall be guilty of an offense, and on conviction thereof

- a) A \$500.00 fine will be issued upon inspection for a missing or non-maintained grease collection system.
- b) Correction of missing and/or satisfaction of Town of Schroon requirements in 30 days or less will be reimbursed \$250.00 of the fine amount.
- c) Fines will continue at \$500.00 per day with no reimbursement after 30 days of noncompliance of the Inspection date.
- d) After 60 days of noncompliance, the business will be ordered closed.
- e) If there is an interruption to the service of the Sewer Main and/or surrounding businesses/residences due to excessive grease build up due to non-existence or unmaintained grease collection system, all incurred cost will be the responsibility of the offending business to return service to all afflicted.
- f) All fines and credits will be added to the owners Water and Sewer Bill

SECTION 3. When a violation of this ordinance or any of the provisions thereof is continuous, each day thereof shall constitute a separate and distinct violation.

SECTION 4. The Town may enforce obedience to this ordinance by injunction.

SECTION 5. Any person violating any of the provisions of this ordinance shall become liable to the Town for any reasonable expense, loss, or damage occasioned by the Town by reason of such violation.

RESOLUTION# 156 Approve up to 30 hours labor to clean out Golf Course Gardens

Councilman Thompson moved a resolution to hire Molly Wissser and Alexie Subra at the rate of \$15.00 and hour and approve up to 30 hours of labor to clean out the Golf Course Gardens, seconded by Councilwoman Welch; carried.

DISCUSSION: Highway Garage Roof

Councilwoman Donaldson moved to table the discussion on the Highway Garage Roof until they have more information on material cost and that all quotes include Prevailing Wage, seconded by Councilman Gero; carried.

DISCUSSION: Senior Citizen Tax – waiting for information on how it affect Town of Schroon

Supervisor Wood stated she had received information from David Wainwright, Director of Essex County Real Property Tax Services, as is stands now; Essex County's income limit is \$25,000 for a 50% exemption. On the 2022 Final Roll there were 502 taxpayers that qualified equaling an exempt amount of \$36,005,723. There are currently 2,621 taxpayers that are receiving the Enhanced STAR exemption. All of these people are aged 65 or over and could possibly qualify for the Senior exemption if the income limit was raised high enough. Since the income limit for the Enhanced STAR was \$92,000 for 2022, all we know is that there are at least 2,621 people aged 65 or older earning less than \$92,000. If the income limit was raised to \$35,000 (also for a 50% exemption) and applied to the bottom 50% of taxpayers that have Enhanced STAR (arraying the parcels by assessed value) it would equal approximately 1,622 parcels and \$95,403,925 in exempt value. If the limit was raised to the maximum of \$50,000 and applied to the bottom 75% of parcels it would equal approximately 2,140 exemptions for an exempt amount of \$141,887,490. These figures are a "best guess", assuming 50% of seniors might earn less than \$35,000 and 75% of seniors might earn less than \$50,000. I will get you more information as it comes in.

DISCUSSION: Update on WiFi service in Town Park

Supervisor Wood stated that Jim Kowalka purchased equipment to be installed this week from the Parks Building to the Pavilion and from there will see how much more we will need to install. We will need to get quotes for cameras for the Boathouse, Bath House and possibly the Bandstand.
