**JOB SUMMARY:** This position involves responsibility for providing emergency medical services to residents of Essex County. The incumbent operates specially equipped medical vehicles in the transport of victims to area hospitals. The incumbent, possessing the appropriate certification level from the New York State Department of Health required for the position, renders initial medical services to persons requiring medical assistance. The incumbent performs routine maintenance and custodial work on station and equipment when not performing the primary responsibility of the class. The work is performed under the general supervision of a higher-level Emergency Medical Technician with considerable leeway in the exercise of independent judgement in carrying out the details of the work. Employees are required to re-certify on a periodic basis the Emergency Medical Technician certification required for the position. The incumbent does related work as required.

**MINIMUM QUALIFICATIONS:**

(A) Possession of a current certification from the New York State Department of Health as an Emergency Medical Technician-Basic and must keep current throughout employment

(B) Possession of a valid license to operate a motor vehicle in New York State, appropriate for the vehicle to be operated.

(C) Possession of CPR Certification that must remain current throughout employment.

(D) Possession of Emergency Vehicle Operations and Training certificate within one year of hire date.

**Residency Requirement:** There is no residency requirement.
