A Public Health Nurse is also responsible for the reevaluation of the health care needs of individuals and families and assessments of the effectiveness of the plans of care and intervention which were provided. The work is performed under the supervision of a Supervising Public Health Nurse. A Public Health Nurse may supervise Registered Professional Nurses and staff assigned to carry out the plans of care. The incumbent does related work as required.

Note: In compliance with OSHA, this position has a potential risk of exposure to bloodborne pathogens (blood/body fluids).

MINIMUM QUALIFICATIONS: Graduation from a regionally accredited or New York State registered four-year college or university with a Baccalaureate degree in Nursing and licensure and current registration to practice as a Registered Professional Nurse in New York State.

**Note:** Your degree must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized as an accrediting agency by the U.S. Department of Education/U.S. Secretary of Education. If your degree was awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency.
